CIRCULAR

On the recommendations of the committee the Vice-Chancellor has been pleased to authorize the following criteria to streamline the hostel accommodation of the University:-

1. In the interest of providing hostel facilities to maximum aspirants for hostel accommodation one year accommodation would be made as a routine.
2. The accommodation shall be provided to the eligible PG- students for the last two semesters of the Programme. However, in case after accommodating the final year students, some accommodation remains available, the Hostel administration can accommodate the aspirant students on the basis of seniority and other stipulated conditions.
3. As per the availability of vacancies, accommodation will be provided to the aspirants from each district proportionately on the basis of distance, number of applicants from each district and relative merit among them.
4. Differently-abled students shall be given 1st preference irrespective of the semester they are studying.
5. 10% reservation is earmarked for the students belonging to outside valley who shall be admitted irrespective of the semester they are studying.
6. The admitted students shall have to complete all formalities within the stipulated time and have to pay hostel charges in advance for the whole period of their accommodation. However, in case of differently abled students (and those who are admitted for more than one year in case accommodation is available after admitting the final year students), hostel fee shall have to be paid for one year in advance.
7. No guest shall be allowed to stay in the hostel without the prior permission of the warden. The guest shall have to pay in advance the mess dues @ Rs. 200/- per day.
8. No boarder of the hostel is permitted to host guest/s for more than five days in a month.
9. For maintaining proper discipline in the hostels the wardens and the proctorial staff shall keep a strict vigil on students and wherever a mala-fide intention is visible the same be reported to the authorities immediately. The Provost and the Chief Proctor shall visit the hostels at least once in a fortnight so that proper discipline is maintained in the hostels.
10. Any violation of hostel rules shall be strictly dealt with including the immediate cancellation of the accommodation of the border.
