The number of students per course per campus shall be 20% of the total number of students admitted to the course subject to the maximum of 30 students per course per campus. The departments shall not forward application forms in excess of the prescribed limit (20%/Max. 30 forms) to the General Section. The concerned Departments shall ensure to forward only such application forms of deserving students after proper screening. The concerned Departments may also intimate the total course strength along with the application forms complete in all respects.
