- A pre-bid meeting will be held to clarify doubts and to answer questions on any matter that may be raised at that stage by the bidders in the office chamber of Registrar University of Kashmir.
- Bids must be accompanied with cost of Tender document in shape of demand draft in favour of **Registrar, University of Kashmir** and Earnest money / Bid security in shape of CDR / FDR/BG pledged to **Executive Engineer Construction Division, University of Kashmir**.
- The date and time of opening of Bids shall be notified on Web Site www.jktenders.gov.in and conveyed to the bidders automatically through an e-mail message on their e-mail address. The **Financial bids of Responsive bidders** shall be opened online on same Web Site in the Office of the Registrar, University of Kashmir (Tender receiving authority).
- The bids for the work shall remain **valid for a period of 120 days from the date of opening of Technical bids**.
- The earnest money shall be forfeited, If:-
 - Any bidder/ tenderer withdraws his bid/ tender during the period of bid validity or makes any modifications in the terms and conditions of the bid.
 - Failure of Successful bidder to furnish the required performance security within the specified time limit.
 - Failure of Successful bidder to execute the agreement after fixation of contract.
- Instruction to bidders regarding e-tendering process.**
 - Bidders are advised to download bid submission manual from the "Downloads" option as well as from "Bidders Manual Kit" on website www.jktenders.gov.in acquaint bid submission process.
 - To participate in bidding process, bidders have to get 'Digital Signature Certificate (DSC)' as per Information Technology Act-2000. Bidders can get digital certificate from any approved Vendor.

- 7.3. The bidders have to submit their bids online in electronic format with digital Signature. No bid will be accepted in physical form.
- 7.4. Bids will be opened online as per time schedule mentioned in Para-1.
- 7.5. Bidders must ensure to upload scanned copy of all necessary documents with the technical bid. Besides, original / photocopies of documents related to the technical bid be submitted physically / by registered post / through courier before date specified in para - 1.

Note: - Scan all the documents on 100 dpi with black and white option.

8. The department will not be responsible for delay in online submission due to any reasons.
9. Scanned copy of cost of tender document in shape of Demand Draft in favour of Registrar University of Kashmir and Earnest Money / Bid Security in shape of CDR/FDR if applicable pledged to Executive Engineer University of Kashmir must be uploaded with the technical documents of the bid. The original Demand Draft (cost of tender document), CDR / FDR (earnest money/bid security) and relevant technical bid documents to be submitted to the tender opening authority by registered post/Courier /by hand before due date of submission of tender/as per time schedule specified.
10. Bidders are advised not to make any change in BOQ (Bill of Quantities) contents. In no case they should attempt to create similar BOQ manually. The BOQ downloaded should be used for filling the item rate inclusive of all taxes and it should be saved with the same name as it contains.
11. **Price escalation and Taxes:-** The unit rates and prices shall be quoted by the bidder entirely in **Indian Rupees** and the rates quoted shall be deemed to include **price escalation and all taxes upto** completion of the work, unless otherwise specified. Deduction on account of taxes shall be made from the bills of the contractor on gross amount of the bill as per the rates prevailing at the time of recovery.
12. Bidders are advised to use "**My Documents**" area in their user on JK Tendering portal to store such documents as are required.

18 Undertakings/ affidavit:-

- a. Authority to seek references from Bidders bankers.
- b. That the bidder would be able to invest a minimum of 15% of Contract Value.
- c. Information regarding any litigation current or during the last five years, in which the bidder is involved, the parties concerned and disputed amount.

- d. That the bidder is not black listed/debarred by any Govt. or Semi-Govt. Departments from participation in tendering.
- e. That bid will remain valid for a period of one hundred and twenty (120) days from the date of opening of Technical bids.
- f. Affirming that the information submitted by the bidder with the bid / supporting documents is true & correct to the best of his knowledge and belief.

Note:-Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirement and/or record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc and/or participated in the previous bidding for the same work and has quoted unreasonably high bid prices and could not furnish rational justification to the employer.

19. The bidder at his own responsibility and risk should visit and examine the site of work and its surroundings before submission of bid.
20. Non attendance of pre-bid meeting will not be cause of disqualification of the bidder.
21. All documents relating to the bid shall be in the English Language.

22. The material shall be of standard quality i.e.

- I. Cement = AMBUJA/ACC/JK Cements/Max or equivalent.
- II. Steel = TATA/SAIL or equivalent.

23. *If the bidder does not quote rate for any item of the rate list/quantity schedule, cost of such item/ items shall be deemed to be part of the overall/total contract value. No rate shall be allowed for such item / items in the allotment of contract.*

24. **General Conditions of Contract:-**

- 24.1. The date of start of the work shall be reckoned within one week from the date of issuance of LOI/Contract allotment as the case may be.
- 24.2. **Penalty for delay in completion:**-In case of delay in completion of work beyond stipulated period of completion, caused by the contractor Rs 2000 per day (Two Thousand per day) subject to the maximum of (2.00 %) Two percent of the Completion cost shall be imposed.
- 24.3. **Time extension:**-Suitable time extension shall be granted in case of increase in scope of work and in the event of delay beyond control of contractor to be determined by the department.
- 24.4. **Advance Payments:**-No mobilization advance/equipment advance shall be paid unless otherwise specified in the SBD.
- 24.5. **Secured Advance:**- No Secured advance shall be paid unless otherwise specified.
- 24.6. **Retention Money:**- 4% (2% CDR +2% Retention money/Bill Deposit) shall be deducted from each running bill of the successful contractor which shall be released after virtual completion of work in all respects.
- 24.7. **Schedule of Payment:**-The payment schedule shall be fixed after award of contract in favour of successful bidder, on the basis of availability of funds and value of work executed, shall be determined by the Engineer.
- 24.8. **Amendment of bidding document:**-Before the deadline for submission of bids the employer may modify the bidding documents by issuing Addenda.
- 24.9. The tender receiving authority reserves the right to accept or reject any tender or all tenders without assigning any reason thereof.
- 24.10. **Unbalanced Bid:**- In case bid of the lowest bidder is found unbalanced, the successful bidder shall have to produce additional performance security in shape of CDR/FDR/BG within (10) days after opening of price bids, as per following break-up:-

24.11. **Restoration of work:-** On completion of contract the contractor shall be responsible to remove all un-used material and restore all work in its original position at his own cost.

24.12. **Traffic regulations:-**The contractor is bound to adhere to traffic regulations as is applicable from time to time and ensure arrangements of smooth regulation of traffic during execution of work.

24.13. **Arbitration:-** The arbitration shall be conducted in accordance with the arbitration procedure stated in the J&K conciliation and Arbitration Act No:-xxxv of 1997 issued vide SRO No:-403 vide Notification of J&K Govt., "Law Department" 11th December-1997.

24.14. **Defect Liability period:-** The DLP shall be Calculated from date of certified completion of work and period shall be 18 months. *The defects noticed in the work during execution or D.L.P. shall be corrected by the Contractor within the length of time specified by the Engineer. If the contractor does not correct the defects pertaining to D.L.P. to the satisfaction of the Engineer within the time specified, the Engineer will assess the cost of having the defects corrected and contractor will pay this amount on correction of defects.*

Safety:- The contractor shall be responsible for safety of all activities at site of work.

24.15. **Discoveries:-** Anything of historical or other interest or of significant value unexpectedly discovered on the site shall be the property of the Govt.

24.16. **Tests:-**The contractor shall be solely responsible for carrying out the mandatory tests required for the quality control at his own cost.

24.17. **Termination:-** The employer may terminate the contract if the contractor causes a fundamental breach of the contract.

25. Fundamental breach of contract will include:-

25.1. Continuous stoppage of Work for a period of 30 days without authorization of Engineer in-charge.

25.2. *Contractor is declared bankrupt.*

25.3. *Any evidence of involvement of contractor in corrupt practices.*

25.4. *Contractor delays the completion of work beyond stipulated time of completion.*

25.5. *Pursuant to the process of termination of defaulted contract, the employer reserves the right to invite fresh tender for the balance work at the risk and cost of defaulting contractor.*

25.6. *If in case contractor failed to start /complete the work, within the stipulated time period, his CDR/Earnest Money shall be forfeited after termination of the contract. Besides, defaulting contractor shall be debarred from taking works in University of Kashmir at least for two year.*

27. **Specification/Quality Control:-** All items of works shall conform to specifications as per IRC/ MORTH/ NBO/ CPWD/ SSR/ other prescribed specifications provided by the University Consultant.
28. **Insurance:-** Insurance cover to Labour / Machinery / Work / Plant material / Equipment by the contractor shall be mandatory.
29. **Laws Governing the Contract:-**The contract shall be governed by Laws of the land.
30. **Court's Jurisdiction:-**In case of any disputes/differences between contractor and Department the jurisdiction shall be J&K State.
31. **Time Extension:-**
- 31.1. *The work is to be completed within the time limit specified in the NIT and the time of completion will also increase / decrease in proportion with additional / deleted quantum of work depending upon the actual quantum of work.*
- 31.2. *Request for extension of time shall be made by the contractor in writing not later than fifteen days of happening of the event causing delay. The contractor shall also indicate in such a request the period for which extension is desired.*
- 31.3. *Abnormal /bad weather or Serious loss or damage by fire or Civil commotion, strike or lockout (other than among the labour engaged by the contractor) affecting any or the trades employed on the work, or Non availability of departmental stores. Any other cause which in the absolute discretion of the accepting authority is beyond the contractor's desire.*
- 31.4. *On contractor's representation based on the grounds as detailed above the time for completion of the work may be extended by a period considered reasonable by the Department.*
- 31.5. *Extension of time shall be also admissible in the event of temporary suspension of work.*
32. *The tender / bid is liable to rejection if it does not fulfill the requirements as laid down in NIT.*
33. Special work will have other conditions as per specification and requirement at site. The special conditions if any will be incorporated in the NIT as and when such Tender Notice is issued.
34. Separate specification for PEB and same nature of specialized job will be incorporated in the particular NIT at the time of Tendering.
35. All the General Conditions laid down in this NIT are applicable to the prime contractor even the contractor having a joint venture with the PEB vender (except Annexure A i.e conditions for PEB works). The prime Contractor shall have to submit all the required documents mentioned in this NIT.
36. All other terms conditions are as per PWD Form 25 (Double leaf agreement Form).

PEB VENDOR PRE-QUALIFICATION (Annexure A)

IN GENERAL

- The PEB Vendor shall furnish all details including their experience in the Application Format, (only and if the space provided is not sufficient, particulars shall be furnished in Annexure and such details shall be mentioned in the respective columns of the Application Format. The authorized person of the contractor shall sign in all the pages of the application with seal of the company/ firm.
- PEB Vendor should submit Application Format along with company profile/ Brochure.
- No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions or site visits will be reimbursed.
- PEB Vendor shall furnish documentary proof with respect to the prequalification criteria along with the application form.
- Incomplete application without proper proofs for establishing their credentials will be liable for rejection and no correspondence will be entertained in this regard.
- The evaluation shall be mainly based on the eligibility criteria, other factors like timely completion, resources of the applicant, pre-qualification with other institutions/ works etc., manpower & logistical support of the applicant, their financial capabilities, quality consciousness, etc. will be considered as added qualifications. If found necessary, the PEB Vendor shall make arrangements to inspect any of the work undertaken by them.
- Applications received after the due date and time shall be rejected.
- University of Kashmir expects that PEB Vendors/Companies/ Firms should furnish all the required documents to ensure a transparent and genuine evaluation, so it is necessary to fill in the Pre-Qualification documents meticulously and sign & stamp each and every page.
- Fill in the Pre-Qualification Documents in writing in Blue/ Black ink or “type”.

PEB WORKS PRE-QUALIFICATION

ELIGEITY CRITERIA

- The PEB Vendor/Firm/contractor may be a registered and recognized entity as per ministry of corporate affairs, Govt. of India. It is clarified that for any joint venture bids the following conditions must be fulfilled:-

1. At least one of the Joint Venture/ Consortium partners must be a company exclusively engaged in the business of design, manufacture and erection of steel Pre Engineered Buildings, and must satisfy the other criteria of the pre qualification.
2. The Joint Venture/ Consortium agreement, including details of role and responsibility if each partner and their share pattern, duly signed by the authorized signatories of each party must form part of the pre- qualification document. Joint Venture date AFTER the date of pre qualification submission will not be allowed.
3. If a Joint Venture/ Consortium is successful in being pre qualified, then it must be agreed by all parties, that in the event of a dispute arising within the Joint Venture partners or a circumstance arising that warrants the legal dissolution of the Joint Venture, the PEB building partner shall remain liable and committed to the completion of the project.
4. The PEB vendor and prime contractor should form joint venture/ Consortium on Non Judicial Paper

- The PEB Vendor should have successfully completed similar works during the last five years ending March 2017. The PEB vendor should have completed the same nature of single work to the tune of Rs 15.00 cr, Two similar works Rs 10.00 Cr, Three similar works Rs 7.00 cr.

- The work means the same as shown on the cover sheet of this document which includes – Pre Engineered Building works including fabrication and erection of steel building, as per the drawings and specifications.

- The PEB Vendor should have Plant Capacity of 300.00 MT/ Month & should have completed PEB building with the minimum floor area of 3000.00 Sqm. Proof or Undertaking for the said conditions should be appended with the hard copy.

- The PEB Vendor should have an average annual turnover of 30.00 Crore (in the last three years ending March 2017) enough to prove the approval / accepting of committee, and the capacity to successfully complete the work.

- The PEB Vendor should have enough capacity in terms of personnel for Engineering and design, labour force both skilled and unskilled, Supervisory staff, equipments, plants and machinery, to satisfactorily complete the job in stipulated time.

- The PEB Vendor shall furnish the list of key employees, employed by him with full details of their previous employment.

- The PEB Vendor shall submit copies of the GST Registration & Returns/ Registration Certificate /PAN Card/ Excise registration forms along with copy of Paid Tax.

The committee reserves the right to verify the particulars furnished by the applicant independently.
