 - I have not availed the benefit of the reserved category certificate for pursuing any UG Programme earlier (if seeking admission under Reserved Category);
 - I shall strictly adhere to the rules and regulations of the University in toto;
 - I understand that in case of any misinformation or concealment of any information or indiscipline or the certificates/documents submitted by me are not genuine or incomplete in any respect <u>as on</u> <u>last date prescribed for submission of On-line Application Form</u>, my admission to the course shall be cancelled and I shall be subjected to legal action;

The provisionally selected candidates shall approach, alongwith all the relevant original certificates and self attested Xerox copies of certificates/documents to the concerned Head of the Department for completion of admission related formalities from 20th of August, 2018 to 04th of September, 2018.
