ADMISSION NOTIFICATION No.18 For M.Pharm Programme (Non-GPAT) (Session 2018)

On-Line Applications are invited from eligible candidates for admission to M.Pharm Programme for the academic session 2018 at Main Campus, University of Kashmir. Admission to the Programme shall be governed by the Admission Policy/PG Prospectus-2018 available on University website and relevant statutes.

i) <u>Important dates:</u>

Submission of On-Line Forms	From September 04, 2018
Last date of submission of On-Line Application Forms/	September 11, 2018
Deposition of Entrance Test Fee	

ii) Eligibility:

Should have passed, Bachelor of Pharmacy (B.Pharm.) from the University of Kashmir or any other Institute recognized by UGC/AICTE with at least 55% marks in aggregate for Open Merit and 50% marks for reserved categories.

iii) Admission Criteria:

Candidates shall be admitted to various specializations of M.Pharm Programme on the basis of merit obtained in the Entrance Test against the available vacant seats.

iv) Submission of On-Line Application Forms:

The candidates are advised to follow the following steps for filling their On-Line Application Forms:

Step-1:	Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions 2018. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.
Step-2:	Enter your " <u>Registration No."</u> and Click " <u>Next</u> ".
Step-3:	Enter the required details and Upload your latest passport size Photograph and click " <u>Next".</u>
Step-4:	Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click " <u>Next".</u>
Step-5:	If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u> . Get a printout of the Form and note the Form No. for future reference.
Step-6:	Deposit the non-refundable " <u>Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) and for</u> <u>Entrance Test Fee of Rs. 500/- plus i.e. Rs. 750/-</u> through Online mode only.

v) Submission of downloaded Application Form (Hard copy):

The candidates after submitting the On-Line Application Form need not to submit the hard copy of the Application Form

vi) Additional information:

- The candidates must check the status of their application forms after four days of online submission of application forms. In case, acceptance of form is not uploaded or fee reconciliation is pending, the candidate should contact the office of the **Directorate of Admissions & Competitive Examinations, University of Kashmir,** along with Application Form, and other relevant documents, within three days after the last date of submission of Application Form. Thereafter, no claim whatsoever will be entertained by the University.
- The candidates are advised to regularly check university website, using log-in and Password for status and necessary instructions and updates.
- After completing the admission process for General Category seats, the notification for self-finance seats shall be issued. However, only those candidates shall be considered for admission in Self Finance seat category who have initially submitted their application forms for admission to General category.
