Consequent upon the vacancies created due to non-completion of admission formalities by some candidates, the candidates whose particulars are mentioned below have been selected provisionally for admission to **2-Year M.Tech** Programme at **SSM College of Engineering, Pattan under Open Merit** purely on the basis of Entrance Test merit obtained by them and preference given at the time of submission of online Application Forms. The admission of the candidates is subject to:

- 1. Production of all relevant original documents {Marks Card/s of qualifying examinations, State Subject certificate, Character, Category Certificate (if applicable) and Provisional certificates of the Institution last attended};
- 2. Fulfilling of minimum required eligibility conditions to be verified by the concerned Department;
- 3. Production of an affidavit sworn in before  $1^{st}$  Class Magistrate stating that:
  - o I am not on rolls of any Institution;
  - o All the submitted certificates/documents are genuine;
  - 0 I shall strictly adhere to the rules and regulations of the University in toto;
  - I understand that in case of any misinformation or concealment of any information or indiscipline or the certificates/documents submitted by me are not genuine or incomplete in any respect <u>as on last date prescribed</u> <u>for submission of On-line Application Form</u>, my admission to the course shall be cancelled and I shall be subjected to legal action;
  - I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.

The provisionally selected candidates shall approach, alongwith all the relevant original certificates and self attested Xerox copies of certificates/documents to the concerned Heads of the Departments for completion of admission related formalities from **December 24, 2018** to **December 26, 2018**. Any provisionally selected candidate, failing to complete the admission formalities by **December 26, 2018**, shall forfeit his/her right to admission. However, those of the candidates who have applied and appeared in the entrance test on provisional basis shall have to be selected subject to the production of Marks Certificates of their qualifying examinations failing which their selection to the programme be treated as forfeited. Please note that all Notifications shall be made available only on the official website of the University and no Notice shall be published in print media.
