ADMISSION NOTIFICATION No. 09 of 2019 For 3-Year B.Voc. Degree Programmes (Session-2019)

On-line Applications are invited from the eligible candidates for admission to the below mentioned B.Voc. Degree Programmes introduced under Deen Dayal Upadhyay (Kaushal) Kendra for the academic session 2019.

a) Automotive Technology;

b) Electronic Media;

Eligibility: The basic eligibility condition for admission to B.Voc programme(s) shall be as under:

Programme	Eligibility	
Automotive Technology	Passed 10+2 or Matric with two years ITI Course in Mechanic Motor Vehicle (MMV) Trade from any recognized Institute or 3-Years Diploma in Automobile Engineering from any recognized Institute or any other candidate possessing certification of NSQF level 03	
Electronic Media	Passed 10+2 in any stream	

The courses are designed to have provision of multiple entry and exit at various levels culminating up-to a research degree level.

- (i) For a One-Year Diploma Programme (level 4&5) shall be two consecutive semesters (one odd and one even semester).
- (ii) For a Two-Year Advanced Diploma Programme (level 6) there shall be four consecutive semesters (Two odd and two even semesters).
- (iii) For Three-Year Degree Programme (level 7) there shall be six semesters, i.e. three odd and three even semesters.

III) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling their On-Line Application Forms.

- **Step-1:** Visit http://www.kashmiruniversity.ac.in and click on Link Admissions **2019.** Read Important Instructions for Registration and Submission of Form carefully before proceeding further.
- **Step-2:** Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the <u>"Register as Student"</u>. Remember, the Username and Password for future reference.
- **Step-3:** After successful Registration, login into the system for submitting On-line Application Form. Enter your "Registration No." and Click "Next".

- **Step-4:** Enter the required details and Upload your latest passport size Photograph and click "Next".
- **Step-5:** Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click "Next".
- **Step-6:** If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u>. Get a printout of the Form and note the Form No. for future reference.
- Step-7: Deposit the non-refundable "<u>Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) and Entrance Test fee of Rs. 500/-</u>" i.e Rs. 750/- for one Programme and Rs. 250/- for each subsequent Programmes, through Online mode only.
- **Step-8:** Applicant can view the Application details by providing username and password. Applicant is required to make sure that "**Application Status**" on application form is "**Fee Received**" after 3 days otherwise application will be treated as incomplete and summarily rejected.

Step-9: Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last minute rush. Please retain print-out of application form for future references.

IV) Submission of downloaded Application Forms (Hard Copy):

- The candidates are required to submit downloaded Application Form (hard copy) with the following documents in the office of the Directorate of Life Long Learning, , University of Kashmir, Hazratbal and obtain a receipt for record.
 - Marks Certificate of the qualifying examinations;
 - State Subject Certificate;
 - Reserved Category Certificate with Xerox as well as original for verification ("Certificate under process" will not be entertained under any circumstance whatsoever.);

V) Additional information:

- Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of appearing in the written examination and it will be the sole responsibility of the candidate to satisfy whether he/she is meeting the prescribed criterion. However, the documents will be verified at any point of time during process of Admission. The admission will be rejected if it is found that the applicant does not fulfill the eligibility criteria or has misrepresented/suppressed the information.
- The candidates must check the status of their Application Forms after three days of its online submission. In case, the status of Application is not updated to <u>"Fee Received"</u> or <u>"Fee Reconciliation is Pending"</u>, the candidate should contact the **Directorate of IT & SS, University of Kashmir**, alongwith Application Form and all other documents, within two days after the last date of submission of Application Form. Thereafter, no claim, whatsoever, will be entertained by the University.
