On-Line Applications are invited from eligible candidates for admission to 4-Years B.Pharm Programme for the academic session 2019 at Main Campus, University of Kashmir. Admission to the courses shall be governed by the Admission Policy/PG Prospectus-2019 available on University website and relevant statutes.

#### i) Important dates:

Submission of On-Line Forms	From 01-06-2019
Last date of submission of On-Line Application Forms	11-06-2019
Last date of submission of Hard copy of Application Forms	12-06-2019

#### ii) <u>Eligibility:</u>

10+2 (Biology background) with 50% marks for Open Merit and 45% for Reserved category.

#### iii) Admission Criteria:

The admission to the programme will be made on the basis of Entrance Test comprising of Objective Type Questions, to be conducted by the University.

#### iv) Submission of On-Line Application Forms:

The candidates are advised to follow the following steps for filling their On-Line Application Forms:

Step-1: Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions 2019. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.
Step-2: Enter your " <u>Registration No."</u> and Click " <u>Next</u> ".
<b>Step-3:</b> Enter the required details and Upload your latest passport size Photograph and click " <u>Next".</u>
Step-4: Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click " <u>Next".</u>
<b>Step-5:</b> If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u> . Get a printout of the Form and note the Form No. for future reference.
Step-6: Deposit the non-refundable " <u>Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) and</u> <u>Entrance Test fee of Rs. 500/-</u> "through Online mode only.

#### v) Submission of downloaded Application Form (Hard copy):

The after submitting the On-Line Application Form candidates must submit the hard copy of the Application Form in the Office of the **Department of Pharmaceutical Sciences**, **University of Kashmir**, alongwith the self-attested copies of the following documents, failing which their candidature will not be considered.

- i) Marks certificates of qualifying examinations;
- ii) Category Certificate, if claiming admission under reserved category;
- iii) State Subject Certificate;

#### VII) Additional information:

- The candidates must check the status of their application forms after four days of online submission of application forms. In case, acceptance of form is not uploaded or fee reconciliation is pending, the candidate should contact the office of the **Department of Pharmaceutical Sciences, University of Kashmir,** along with Fee Receipt, and other relevant documents, within three days after the last date of submission of application forms. Thereafter, no claim whatsoever will be entertained by the University.
- The candidates are advised to regularly check university website, using log-in and Password for status and necessary instructions and updates.
- After completing the admission process for General Category seats, the notification for self-finance seats shall be issued. However, only those candidates shall be considered for admission in Self Finance seat category who have initially submitted their application forms for admission to General category.
