Consequent upon the vacancies created due to non-completion of admission formalities by some candidates, the candidates whose particulars are mentioned below have been selected provisionally for admission to 5-Year BA-LLB Programme under Open Merit and Reserved Category (ies) at **private affiliated Law Colleges** purely on the basis of Entrance Test Points obtained by them in the Entrance Test. The admission of the candidates is subject to:

- 1. Production of all relevant original documents {Marks Card/s of qualifying examination, Reserved Category Certificate (if selected under any reserved category except OSJ), State Subject certificate, Character and Provisional certificates of the Institution last attended};
- 2. Fulfilling of minimum required eligibility conditions to be verified by the concerned Departments;
- 3. Production of an affidavit sworn in before 1st Class Magistrate stating that:
 - o I am not on rolls of any Institution;
 - o All the submitted certificates/documents are genuine;
 - o I shall strictly adhere to the rules and regulations of the University in toto;
 - o I understand that in case of any misinformation or concealment of any information or indiscipline, my admission to the programme shall be cancelled and I shall be subjected to legal action;
 - o I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.

The provisionally selected candidates shall approach, alongwith all the relevant original certificates and self attested Xerox copies of certificates/documents to the concerned **Principals of the Colleges**, for completion of admission formalities from **November 30, 2019 to December 04, 2019**. Any provisionally selected candidate failing to complete the admission formalities upto **December 04, 2019** shall forfeit his/her right to admission.

The Principals of the Colleges shall ensure that;

- the selection of the candidates to the programme shall not exceeding the approved intake capacity;
- the candidates in waiting list must have to approach the concerned Colleges on **November 24, 2019** and submit an application for seeking admission against the vacant seat (if any), accordingly such applications shall have to be consolidated as per merit and forwarded the same to the Directorate of Admissions & Competitive Examinations, University of Kashmir on **December 05, 2019 upto 04:00 PM** for obtaining admission confirmation.
