## Admission Notification (Under Choice Based Credit System Semester Scheme) for Under-Graduate 5<sup>th</sup> & 6<sup>th</sup>Semester of Batch 2017 (Regular)

It is notified for the information of all concerned candidates that the Hon'ble Vice-Chancellor has pleased to authorize the B.A/B.SC/B.COM/B.C.A/B.B.A/B.M.M.M.C/OCMIL/FAZILA(CBCS) 5<sup>th</sup>& 6<sup>th</sup>semester admission on **Provisional Basis (as a special case)**. The admission formalities for completion of admission in the affiliated colleges of the University shall be available from **04-12-2019 up to 31-12-2019** on the following terms and conditions:

- All the candidates of B.A/B.Sc/B.Com/BCA/BBA/BMMMC/OCMIL/FAZILA (3<sup>rd</sup> and 4<sup>th</sup> Sem) Batch 2017 shall be eligible for admission. The dropout candidates of Batch 2015/16 & Annual scheme batches (2<sup>nd</sup> year), who have not sought admission in 5<sup>th</sup>& 6<sup>th</sup> Semester are also eligible for admission.
- The candidates of Batch 2017 (only) seeking admission in 5<sup>th</sup>& 6<sup>th</sup> Semester shall visit the ii. Information Cell of the College concerned for Enrolment Sheet and do not need to download any Admission form. However, the candidates of Batch 2015-2016 & Annual Scheme, seeking admission in 5<sup>th</sup>& 6<sup>th</sup> Semester, shall have to submit the Online Admission Form available on the University Website. In case of any discrepancy related to online form submission, the candidate shall visit the Information Cell of the College (with all Original documents) in which he/she intends to seek admission. The said form will be available on the University website (www.kashmiruniversity.net).
- iii. The candidates have to submit the Enrolment Sheet (Batch 2017)/downloaded Admission form (Batch 2016 & older) for 5<sup>th</sup>& 6<sup>th</sup> semesters in the college concerned with a specific subject combination as per syllabus in vogue.
- iv. The College, making use of the unique Form No.s printed on the Form shall accept the new form on the University on-line portal.
- v. The College shall assign the subjects online as mentioned by the candidate in Enrolment Sheet/ Admission form.
- vi. For (a) Confirmation of subjects (assigned online by the College) and

(b) Submission of requisite fee in the College concerned,

The candidate is required to check **MyFormStatus** page (available on University Website <u>www.kashmiruniversity.net</u>)by entering his/her University Registration No.

- vii. The candidate needs to <u>confirm the subjects (assigned online by the College)on MyFormStatus</u> <u>page, strictly prior to the generation of Fee Receipt</u>.
- viii. If the <u>subjects shown on the MyFormStatus page are not as per the choice of candidate</u>, <u>he/she shall immediately visit College Information Cell for subject correction within stipulated</u> <u>time (before Fee Receipt generation)</u>.
- ix. After online <u>Subject confirmation&Fee Receipt</u> generation by the candidate on MyFormStatus Page, <u>no subject changes whatsoever shall be allowed</u>.

- x. Afterwards, the candidate shall opt the mode of Fee Payment as available.
- xi. The fee payment through **Receipt Mode** can be deposited at any Finacle Branch of J&K Bank.
- xii. The candidates have to submit requisite admission and examination fee for 5<sup>th</sup>& 6<sup>th</sup>Semester as per fee structure in vogue.
- xiii. It shall be incumbent upon all the candidates admitted to the course, to attend classes regularly as their attendance shall be counted with effect from the date of start of class work.

Principals of all affiliated Colleges shall forward the information/report/Registration Return along with prescribed Fee Report (generated online) in the office of the undersigned within 10 days after closure of admission.

Payment done by other means including bank drafts shall not be accepted.
