On-Line Applications are invited from eligible candidates for admission to 4-Years B.Pharm Programme for the academic session 2020 at Main Campus, University of Kashmir. Admission to the courses shall be governed by the Admission Policy/PG Prospectus-2020 available on University website and relevant statutes.

#### i) Important dates:

Submission of On-Line Forms	29-10-2020
Last date of submission of On-Line Application Forms	09-11-2020
Last date of submission of Hard copy of Application Forms in respect of candidates applying under any reserved category	12-11-2020

#### ii) Eligibility:

10+2 (Biology background) with 50% marks for Open Merit and 45% for Reserved category.

#### iii) Admission Criteria:

The admission to the programme will be made on the basis of Entrance Test comprising of Objective Type Questions, to be conducted by the University.

#### iv) Submission of On-Line Application Forms:

The candidates are advised to follow the following steps for filling their On-Line Application Forms:

- **Step-1:** Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.
- **Step-2:** Enter your "Registration No." and Click "Next".
- **Step-3:** Enter the required details and Upload your latest passport size Photograph and click "Next".
- **Step-4:** Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click "Next".

- **Step-5:** If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u>. Get a printout of the Form and note the Form No. for future reference.
- Step-6: Deposit the non-refundable "Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) and Entrance Test fee of Rs. 500/- "through Online mode only.

### v) Submission of downloaded Application Form (Hard copy):

After submitting the On-Line Application Form the candidates applying under any Reserved Category must submit the hard copy of the Application Form in the Office of the **Department of Pharmaceutical Sciences, University of Kashmir**, alongwith the self-attested copies of the following documents, failing which their candidature will not be considered.

- i) Marks certificates of qualifying examinations;
- ii) Category Certificate, if claiming admission under reserved category;
- iii) State Subject Certificate;

#### VII) Additional information:

- The candidates are advised to regularly check university website, using log-in and Password for status and necessary instructions and updates.
- After completing the admission process for General Category seats, the notification for self-finance seats shall be issued. However, only those candidates shall be considered for admission in Self Finance seat category who have initially submitted their application forms for admission to General category.
