On-Line Applications are invited from eligible candidates for admission to M.Pharm Programme (Non-GPAT candidates) for the academic session 2020 at Main Campus, University of Kashmir. Admission to the courses shall be governed by the Admission Policy/PG Prospectus-2020 available on University website and relevant statutes.

i) **Important dates:**

ii) **Eligibility:**

Should have passed, Bachelor of Pharmacy (B.Pharm.) from the University of Kashmir or any other Institute recognized by UGC/AICTE with at least 55% marks in aggregate for Open Merit and 50% marks for reserved categories,

iii) **Admission Criteria:**

The admission will be made on the basis of Entrance Test comprising of Objective Type Questions, to be conducted by the University.

iv) **Submission of On-Line Application Forms:**

The candidates are advised to follow the following steps for filling their On-Line Application Forms:

Step-1: Visit <http://www.kashmiruniversity.net> or www.kashmiruniversity.ac.in and click on Link Admissions 2020.

Step-2: Enter your "**Registration No.**" and Click "**Next**".

Step-3: Enter the required details and Upload your latest passport size Photograph and click "**Next**".

Step-4: Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click "**Next**".

Step-5: If there is any variation click on "**Previous**" button, make necessary corrections and then Click "**Submit**". Get a printout of the Form and note the Form No. for future reference.

Step-6: Deposit the non-refundable "**Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) and Entrance Test Fee of Rs. 500/- plus i.e. Rs. 750/-** through Online mode only.
