  - I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.

The provisionally selected candidates shall approach, alongwith all the relevant original certificates and self attested Xerox copies of certificates/documents to the concerned Head of the concerned Department for completion of admission related formalities from **March 04, 2021 to March 09, 2021**. Any provisionally selected candidate, failing to complete the admission formalities by **March 09, 2021**, shall forfeit his/her right to admission.
