i) <u>Important</u> dates:

Issuance of On-line Application Forms	October 28, 2021
Last date of submission of On-line Application Forms including deposition of Fee	November 09, 2021

ii) Eligibility:

The candidates should have passed the 3-year Diploma with at least 50% marks from State Board of Technical Education or from a recognized University/Board in the concerned/relevant branch of Engineering wherein he/she is seeking admission or B.Sc. graduates with Mathematics as one of the subject from a recognized University, with a minimum of 50% marks in aggregate. However, the candidates applying under any reserved category shall have obtained at least 45% marks in 3-Year Diploma programme.

Furthermore, candidates having passed Diploma in below mentioned disciplines are also eligible against the branch of Engineering mentioned;

iii) Admission Criteria:

The admission will be made on the basis of Entrance Test comprising of Objective Type Questions, to be conducted by the University. Syllabus of the Entrance Test is available on the website.

iv) Submission of On-Line Application Form:

The candidates are advised to follow the below steps for filling their On-Line Application Forms.

Step-1: Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions Window and click on link Application Form for B.Tech/BE Lateral Entry.

Step-2: Candidate need to enter their Registration No. and click.

Step-3: Fill in the required details including academic details and Upload your latest passport size Photograph and Click Next

Step-4: Select the desired Programme and preference.

Step-5: Preview the Form displayed on the screen. If details are correct, click on Submit. If there is any variation click on previous button, make corrections and then Submit. Get a printout of the Form and note the Form No. for future reference.

Step-6: Deposit the Application Fee of Rs. 250/- (including IT fee of Rs. 150) plus Entrance Test Fee of Rs. 500/- i.e. Rs. 750/- through Online mode only.

v) Submission of downloaded Application Forms (Hard copy):

The candidates after submitting their On-Line Application Form need not to submit the downloaded Form (hard copy) instead they shall retain the hard copy for future reference. However, if the candidate got selected he/she had to submit all the required documents/certificates in original for verification and further necessary action. In case of any misinformation or the certificates/documents found not valid or incomplete in any respect <u>as on last date prescribed for submission of On-line Application Form</u>, his/her admission to the programme shall be cancelled and he/she shall be subjected to legal action.
