On-Line Applications are invited from eligible candidates for admission to M.Pharm Programme (Non-GPAT candidates) for the academic session 2023 offered at Main Campus, University of Kashmir. Admission to the course shall be governed by the Admission Policy/PG Prospectus-2023 available on University website and relevant statutes.

i) Important dates:

Last date of submission of On-line Application Forms and deposition of On-line Entrance Test Fee	18-08-2023

ii) Eligibility:

Should have passed, Bachelor of Pharmacy (B.Pharm.) from the University of Kashmir or any other Institute recognized by UGC/AICTE with at least 55% marks in aggregate for Open Merit and 50% marks for reserved categories,

iii) Admission Criteria:

The admission will be made on the basis of Entrance Test comprising of Objective Type Questions, to be conducted by the University.

iv) Submission of On-Line Application Forms:

The candidates are advised to follow the following steps while filling their On-Line Application Forms:

Step-1: Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions 2023.

Step-2: Enter your "Registration No." and Click "Next".

Step-3: Enter the required details and Upload your latest passport size Photograph and click "Next".

Step-4: Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click "Next".

Step-5: If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u>. Get a printout of the Form and note the Form No. for future reference.

Step-6: Deposit the non-refundable "Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) and Entrance Test Fee of Rs. 500/- plus i.e. Rs. 750/- through Online mode only.

I) Submission of downloaded Application Forms (Hard copy):

The candidates after submitting their On-Line Application Forms need not submit the hard copies of the Application Form but have to keep with themselves for future reference.
