- 3. The quorum for the meeting including the Chairperson, but excluding the Special invitee, shall be three (03);
- 4. In considering the grievances before it, the SGRC shall follow principles of natural justice and the SGRC shall definitely ensure a transparent, Student Centric mechanism for resolving conflicts, fostering a positive academic atmosphere;
- 5. Any student aggrieved by the decision of the Students, GRC may prefer an appeal to the Ombudsperson, within a period of fifteen (15) days of receipt of such decision.
