#### Important Notes:-

The Principals of all the concerned colleges shall ensure that all the selected candidates possess the minimum required eligibility and have passed their qualifying examination/ have category certificate (if selected under any reserved category) issued by the competent authority. The same shall be verified with the original documents/certificates of the candidate. The admission of the candidates is subject to the:-

- Production of all relevant original documents {Marks Card/s of qualifying examination, Provisional and Character Certificates of the Institution last attended, Valid Reserved Category Certificate (wherever applicable);
  - Production of eligibility cum revival of registration/migration form wherever applicable alongwith prescribed fee;
  - Fulfilling of minimum required eligibility conditions to be verified by the concerned college;
1. The college shall not charge admission/tuition fee from the selected students beyond the fee structure fixed by the State Government/ affiliating University.
  2. In no case whatsoever, no admission shall be made by the college on its own.
  3. The Assistant Registrar, Registration Section is requested not to accept the RR's beyond the approved intake and forthwith return the RR's, if any to the college, so as to rule out the possibility of litigation or regularization of unauthorized admissions. The Assistant Registrar, Registration Section is further requested to report back to this office within 20 days about unauthorized admission if any
  4. Any provisionally selected candidate failing to complete the admission formalities upto **25<sup>th</sup> Aug 2025**, shall forfeit his / her admission if the last date is not extended.

**Note:-** Candidates who have passed 10+2 examination from from any study Centre of NIOS functioning in UT's of J&K shall be required to obtain an equivalence certificate of their degree from J&K BOSE by or before 30<sup>th</sup> Aug, 2025, failing which their candidature should not be considered.
