- I) The Candidates, whose particulars are mentioned in the selection lists appended to this notification, have been provisionally selected for admission to PG, 5-Year BA-LLB, Integrated, B.Tech, Management, Diploma and Certificate Courses/Programmes under General/Self-finance Quota offered by this University purely on the basis of Entrance Test score, CMAT/UGAT Score and/or Qualifying Merit as per admission policy.
- II) Provisionally selected candidates are required to download their "Admission Form" from the official website of the University under "Admissions" tab on the home page and click on "Submit Admission Form for 1st Semester" from 11th September 2025 (Tuesday) by entering Roll Number or Form Number and DOB.
- III) Fresh candidates (who haven't applied earlier) shall visit the Directorate of IT&SS for filling the application form and then only they can download the admission form.
- IV) The provisionally selected candidates shall complete the admission form and visit the concerned Department for completing the admission formalities by or before Monday, 15th September 2025 (4:00 p.m.) on working days only.

Important Note:

The Heads/Directors/Coordinators/Principals, of all the concerned Departments/Institutes/Centres/Campuses/affiliated Colleges, who are the Chairpersons of Departmental Admission Committee, shall ensure that all the provisionally selected candidates possess the minimum required eligibility. The same may be verified with reference to the original documents/certificates of the candidate. The admission form of only eligible candidates should be accepted online and provisionally selected candidates allowed depositing online fees.

The admission of the candidates is subject to:

1. Production of all relevant original documents [Marks Certificate/Transcript of

qualifying examination, Character and Provisional certificates, Reserved Category Certificate, Migration Certificate (wherever applicable)].

Note: Since result has been recently declared and most of the candidates have to seek exit from their colleges, they may be allowed to submit NAD generated 'semester-wise marks cards' till they get the Official Transcript from the University.

- 2. Production of eligibility cum revival of registration/migration form, wherever applicable, alongwith prescribed fee;
- 3. Fulfilling of minimum required eligibility conditions to be verified by the concerned Department/Centre/Institute/Campus/College;
- 4. Clearance be sought from the Academic Section in respect of candidates having qualified examination from Universities/Institutions other than Universities/Institutions of Jammu, Kashmir and Ladakh;
- 5. Production of an affidavit sworn in before 1st Class Judicial Magistrate stating that:
 - ✓ I am not on rolls of any Institution for any regular programme;
 - ✓ All the submitted certificates/documents are genuine and authentic;
 - ✓ I shall strictly adhere to the rules and regulations of the University of Kashmir *in toto*;
 - ✓ I understand that in case of any misinformation or concealment of any information or indiscipline or misconduct, my admission to the programme shall be cancelled and I shall be subjected to legal action;
 - ✓ I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.
- 6. The provisionally selected candidates shall approach, alongwith the admission form and all the relevant certificates and documents (original and self-attested Xerox copies) to the concerned Department/Institute for verification of documents/ certificates and online acceptance of Admission form for depositing the prescribed Fee via online mode upto 15th September 2025.
- 7. Any provisionally selected candidate failing to complete the admission formalities upto 15th September 2025 (4:00 p.m.) shall forfeit his/her right to admission and the resultant vacancy (ies), if any, shall be filled up from among the waiting list.
- 8. The Heads/Directors/Principals are hereby informed to kindly forward the vacancy list (if any) on 15th September 2025 upto 04:30 p.m., so that waiting list is operated.
- 9. Please note that all the Notifications shall be made available only on the Official website of the University and notices shall not be published in print media nor shall any candidate be informed individually.
