ADMISSION NOTIFICATION No. 26 of 2026/DM **2-Year B.Ed. Programme (Distance Mode)** **Academic Session-2026-2027 (Batch-2026)**

On-line applications are invited from the eligible candidates for admission to **B.Ed. Programme** Offered through Centre for Distance & Online Education (erstwhile Directorate of Distance Education), University of Kashmir for academic session **2026-2027**. The candidates are advised to peruse the Admission Policy and other relevant statutes pertaining to Distance Mode admissions on CDOE website thoroughly and check eligibility/other details before submitting their Application Forms.

I) Eligibility:

- The candidates possessing Bachelor's Degree (10+2+3 Pattern) with at least **50% marks for (General Category) and 45% marks for (Reserved Category)** or in the **Master's Degree in sciences/Social Sciences/Humanities or Bachelor's in Engineering or Technology** with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto from university of Kashmir or any other recognized University are eligible for admission to the programme.
- Trained In-service teachers** serving as full time teachers in the **Government or Government recognized private schools (Elementary/School Education)** with minimum of **six months experience***.

OR

- Candidates with NCTE recognized **Teacher Education Programme (D.El.ED)** through face to face mode.

** Experience certificate should be issued by the concerned Head of the Institution.*

II) Selection procedure:

Selection of the candidates shall be based on the academic merit of qualifying examination of the candidate. **However, if the number of the applications exceeds 1:3 ratio of the intake capacity, entrance test shall be conducted by the Director, Admissions and Competitive Examinations.**

III) Important dates

On-line submission and last date for Application Forms from 29-07-2026 to 06-08-2026.

IV) Territorial Jurisdiction:

Kashmir Division including Kashmiri Migrants; however, OSJ category is open to all candidates residing outside Kashmir Division and having passed their qualifying examination from Universities/Institutions other than the Kashmir Division.

V) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling of On-Line Application Forms.

Step-1: Visit <http://www.kashmiruniversity.net> or www.kashmiruniversity.ac.in and click on Link **Admissions**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

Step-2: Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the **"Register as Student"**. Remember, the Username and Password for future reference.

Step-3: After successful Registration, login into the system for submitting On-line Application Form.

Step-4: Enter the required details and Upload your latest passport size Photograph and click **"Next"**.

Step-5: Upload your Marks Certificate of qualifying examination and teaching experience/D.Ed or D.E I.Ed certificate and click **"Next"**.

Step-6: If there is any variation click on **"Previous"** button, make necessary corrections and then Click **"Submit"**.

Step-7: Deposit the non-refundable Online fee of Rs. 900/- . Get a printout of the Form and note the Form No. for future reference.

Step-8: Applicant can view the Application details by providing username and password. Applicant is required to make sure that "Application Status" on application form is **"Fee Received"** after 3 days otherwise application will be treated as incomplete and summarily rejected. Under such conditions, candidates can post a query through online mode only

Step-9: Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush.

VI) Hard Copy of Application Form and fee receipt:

A Candidate need not submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and fee receipt and retain it for future reference.

VII) Disclaimer:

Directorate will not check/verify the academic/category certificates etc. of the candidates at the time of Online submission of application form and it will be the sole responsibility of the candidate to ascertain that he/she fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the concerned Centre at the time of completion of admission related formalities in respect of the provisionally selected candidates to

a particular programme. The admission of a provisionally selected candidate will be rejected at any time if it is found that the applicant was not fulfilling the eligibility criteria on the date fixed for the purpose or has misrepresented/concealed any facts/information;

VIII) Other relevant information:

- **Application Form/Fee Reconciliation Status:**

A candidate must check the status of their Application Forms after three days of its online submission. In case, the status of his/her Application form is not updated to **“Fee Received”** or **“Fee Reconciliation is pending”**, a candidate should post a query online from the dashboard and if a query does not get resolved, a candidate may contact the **IT Cell adjacent to DSW Office Near Rumi Gate, University of Kashmir**, alongwith Application Form, Fee receipt and all other documents, within two days after the last date of submission of Application Form i.e. upto **06-08-2026**; thereafter, no claim, whatsoever, will be entertained by the University;

- Number of seats for B.Ed programmes at the Centre for Distance and Online Education, University of Kashmir is **500** for session 2026-27.
- Reservation policy adopted by the University shall be implemented for the current batch. However, the Supernumerary quota shall be included in the approved intake.
- The duration of the programme is of 02 academic years and admission fee shall be Rs.17,307/- per year.
