**Notice**

Applications on the prescribed format are invited from desirous eligible students of batch-2023 (Main and Satellite Campuses) of the University for grant of Financial Assistance under Students Aid Corpus Fund Scheme (SACFS). Students whose family income is less than Rs 2.0 lac per annum shall be eligible to apply for the purpose. However, preferential order for providing Financial Assistance shall be as under:-

- Orphan/s belonging to AAY Category
- Orphan/s belonging to BPL Category
- Candidates belonging to AAY Category
- Candidates belonging to BPL Category
- Candidates belonging to abandoned/broken family category
- Other eligible candidates

**PROCEDURE/STEPS TO BE FOLLOWED:**

- i) The candidates belonging from AAY/BPL category shall have to attach the relevant certificate/s issued by the concerned Tehsildar with the application form.
- ii) The candidates claiming financial assistance under orphan category shall attach death certificate in support of his/her claim.

The eligible students shall submit the applications on the prescribed format duly completed in all respects in the offices of respective Heads/Coordinators/Directors of the PG Departments/Centres/Campuses **by or before 20<sup>th</sup> March, 2024**.

The concerned Heads/Coordinators/Directors of the PG Departments/Centres/Campuses shall forward the applications duly recommended by Departmental Committee to the office of the Dean Academic Affairs **by or before 27<sup>th</sup> March, 2024** as per the following:
