## Counselling Notice 2-Year B.Ed. Programme (Distance Mode) (Session-2023-24)

It is notified for information of all concerned, that in view of availability of seats which remained vacant due to non-completion of admission formalities by some selected candidates, the candidates who are figuring in the updated General Merit list of 2-Year B.Ed. programme (Distance Mode) and have obtained the academic percentage as mentioned below against each category/chapter, that their Counselling has been scheduled on **14-04-2024 from 10:00 AM to 03:00 PM.** at **Centre of Distance and Online Education, University of Kashmir** for filling up the resultant vacancies in the said programme. Only those candidates are eligible to appear in the Counselling session who have passed the required Qualifying examination and have obtained the academic percentage as mentioned below. Moreover, the Counselling session is not meant for those candidates who have got selected in the already issued selection lists. **The candidates belonging to Kashmir Chapter shall have to download the Counselling Form from University of Kashmir website and submit the same alongwith Xerox copy of Graduation marks certificate in the Centre of Distance and Online Education at the time of Counselling i.e. 14-04-2024 upto 3:00 PM.**

Furthermore, the candidates for Jammu Chapter (including OSJ candidates), Leh Chapter and Kargil Chapter can download the Counselling Form from the University of Kashmir website [www.kashmiruniversity.net](http://www.kashmiruniversity.net) and have to fill the details in the said Counselling form. After filling the details, the same shall have to be forwarded alongwith the Graduation marks certificate in PDF format to the Centre of Distance and Online Education via email [dde@uok.edu.in](mailto:dde@uok.edu.in)
