On-Line Applications are invited from eligible candidates for admission to **MA Philosophy Programme** for the academic session 2024 offered at Main Campus, University of Kashmir. Admission to the programme shall be governed by the Admission policy available on University website and relevant statutes governing the programme.

i) Important dates:

Submission of On-Line Forms							From 11-10-2024

ii) <u>Eligibility:</u>

Graduation in any discipline with 45% marks for Open Merit and 40% for Reserved Category candidates. However, 50% of the seats shall be reserved for the candidates with philosophy as one of the subjects in Graduation

iii) Admission Criteria:

The selection to the programme shall be made on the basis of score obtained in the Entrance Test for which notification will be issued separately;

iv) Submission of On-Line Application Form:

The candidates are advised to follow the below steps for filling their On-Line Application Forms.

Step-1: Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions
Step-2: Enter your Board " <u>Registration No."</u> and Click " <u>Next</u> ".
Step-3: Enter the required details and Upload your latest passport size Photograph and click " <u>Next".</u>
Step-4: If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u> . Get a printout of the Form and note the Form No. for future reference.
Step-5: Deposit the non-refundable " <u>Application Fee of Rs. 250/- (including Rs. 100/- as IT Fee) and</u> <u>Processing fee of Rs. 500/- for one programme i.e. Rs. 750/-</u> "through Online mode only.

v) Submission of downloaded Application Form (Hard copy):

After submitting the On-Line Application Form, candidate need not to submit the downloaded Form (hard copy) but had to retain with themselves for future reference.

vi) Verification of documents/certificates:

- Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of submission of online Application Form and it will be the sole responsibility of the candidate to make sure if he/she is meeting the prescribed criterion. However, the documents will be verified at any point of time during process of Admission.
- <u>The selection of the candidate will be rejected if it is found that the applicant does</u> <u>not fulfill the eligibility criteria or has misrepresented/suppressed the information.</u>

vii) Additional information:

- The candidates must check the status of their Application Forms after three days of its online submission. In case, the status of Application is not updated to <u>"Fee Received"</u> or <u>"Fee Reconciliation is Pending"</u>, the candidate should contact the Directorate of IT & SS, University of Kashmir, alongwith Application Form and all other documents, within two days after the last date of submission of Application Form. Thereafter, no claim, whatsoever, will be entertained by the University.
- <u>Submission of Application Forms are subject to determination of eligibility for</u> <u>admission to the Programme by reference to the statues governing the programme</u>.
