Pursuant to the issuance of Provisional selection lists by the University for Admission to B.Ed course (session 2024-2026), the principals of the respective affiliated colleges shall forward the registration returns within 40 days from the date of issuance of the selection list. Late fee for late submission of RR shall be charged as under:-

The Principals shall forward the RR as per the format devised (in digital format along with hard copy) duly signed by the Principal along with the requisite fee and below mentioned documents/certificates for determining eligibility of candidates to the course and completion of Registration.

### A. Non Local Candidates

**1**. 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> year Marks Certificates in original/ any other examination passed by the candidate;

**2.** Original Inter University Migration Certificate from the parent University/ Institution last attended;

**3.** Original qualification certificate, if available;

**4.** Genuineness report of the category certificates from the issuing authority (where the admission was sought on the basis of category certificate);

**5.** One set of the Photostat copies of the above certificates duly attested by the concerned principal;

### B. Local candidates

**6.** One set of the Photocopies of the marks certificates of examinations previously passed by the candidates duly attested by the concerned principal after original seen;

**7.** Revival of Registration application form along with Migration certificate (in original) and fee of Rs 400/- for the candidates who have joined the course after Migration from this University (where ever applicable).

**8.** Genuineness report of the category certificates from the issuing authority (where the admission was sought on the basis of category certificate) duly forwarded by office of the Dean College Development Council;

**9.** Adhaar card of the candidates (xerox) duly attested by the concerned college principal.
