Applications on prescribed Application Form along with details of qualification, experience and contribution to profession/research are invited for the positions of **Registrar** and **Controller of Examinations** in the University of Kashmir. The posts are on tenure basis for a period of **O3 years**.

PAY SCALE: Level 14 of Pay Matrix Rs. 144200-218200/- (Pre-revised: PB4, Rs. 37400-67000/- with GP of Rs. 10,000/-) and other benefits as admissible from time to time.

LAST DATE OF SUBMISSION OF APPLICATION FORMS: 27-10-2018.

QUALIFICATIONS:

- a. Master's Degree with at least 55% marks or an equivalent grade 'B' in the UGC 7 point scales.
- b. At least 15 years of experience as Assistant Professor in Level 11 of Pay Matrix Rs. 68900-117200/- (Pre-revised : PB-3, AGP Rs.7000) and above or with 8 years' of service in Level 12 of Pay Matrix Rs.101500-167400/- (Prerevised: PB-3, AGP Rs. 8000) and above including as Associate Professor alongwith experience in educational administration. OR

Comparable experience in Research Establishments and/or other Institutions of Higher Education.

OR

15 years of administrative experience of which 8 years shall be as Deputy Registrar <u>in Level 12 of Pay Matrix Rs. 78800-209200/- (Pre-revised:</u> PB-3, GP Rs.7600/-) or an equivalent post.

AGE: The age of superannuation, as at present, shall continue to be 60 years.

OTHER CONDITIONS:

- i) Candidates who have been awarded post-graduate/Ph.D degree from foreign University should enclose "Equivalence Certificate" issued by the Association of Indian Universities (AIU), New Delhi, without which their candidature will not be considered.
- ii) Relevant grade which is regarded as equivalent of 55% wherever the grading system is followed by recognized university shall also be considered eligible.
- iii) The appointment shall be governed by the rules and regulations of the University, University Grants Commission and the Union Ministry of Human Resource Development, whichever is applicable.
- iv) The post shall not be inter-changeable with any other post/s in the similar PB & GP.
- v) Only those candidates should apply for the post, who fulfil all the eligibility criteria by the last date laid down in the advertisement notice by the University.
- vi) The University reserves the right not to fill the vacancy advertised, if circumstances so warrant, without assigning any reason thereof.
- vii) The appointment shall be purely on tenure basis.
- viii) Appointee shall be required to join his /her parent department / institute after completing the term, if applicable.
