II) PERCENTAGE EQUIVALENCE OF GRADE POINTS FOR A SEVEN POINT SCALE:

In the Seven Point Scale with letter grades O, A, B, C, D, E & F, "B" shall be regarded as equivalent of 55%, wherever the grading system is followed:

A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19th September, 1991.

III) SUBMISSION OF ON-LINE APPLICATION FORMS:

- **Step 1:** Visit <u>http://www.kashmiruniversity.ac.in</u> and <u>Click</u> on **Jobs/Recruitment** link. Read detailed important Instructions and Preview of whole process for Registration and submission of Application Form before proceeding ahead.
- **Step 2:** Candidate needs to register himself/herself before submitting the Online Application. For Registration, <u>Click</u> on the <u>Register as an Applicant</u> link. Remember the Username and Password for future reference. Use valid Email id and mobile during registration process.
- **Step 3:** After successful Registration, <u>Login</u> into the system by using your <u>Username</u> and <u>Password</u>.
- Step 4: Key in the personal details, educational qualifications, experience etc then <u>Preview</u> the Form. If details are correct, Click on <u>Submit</u>. If there are variations or you want to update, Click on <u>Preview</u> button, make corrections, updating and then Submit. <u>Remember, no editing or updating is allowed after the Form is submitted</u>. Get a print out and note the Form No. for future reference.
- **Step 5:** Deposit the Application Fee of **Rs. 1050/-**, through Online mode only. *However, the persons with benchmark disabilities (PwD) are exempted from payment of application fee.*

IV) SUBMISSION OF DOWNLOADED APPLICATION FORMS (HARD COPY)

Submit a Print-out of the Application Form submitted online along with the enclosures, duly numbered at right hand top margin, as per the auto-generated serial numbers against each entry, online payment acknowledgement, properly bound, either personally or through Speed Post/ Registered Post to the Office of the Recruitment Section, New Admin Block, University of Kashmir, Hazratbal, Srinagar-190006, J&K.

V) GENERAL INSTRUCTIONS:

- a) In addition to Pay Band/ Pay Level, D.A. Medical Allowance, House Rent and other allowances as admissible to the staff of the Population Research Centre is payable to the appointees.
- b) The appointee is not entitled to GP fund/ pension, however, Contributory Provident Fund/ NPS/ gratuity and leave encashment will be applicable to the appointee as permissible under rules/ guidelines of the Ministry.
- c) Terms and conditions of appointment of the candidates shall be governed by the provisions of the Kashmir & Jammu Universities Act, 1969, and Statutes & Regulations made there under from time to time, and the Union Ministry of Health and Family Welfare, UGC, whichever applicable.
- d) The University reserves the right not to fill up the post advertised, if circumstances so warrant, without assigning any reason thereof.
- e) No TA/DA shall be paid to the candidates for appearing in the interview.
- f) Only those candidates should apply for the posts, who fulfill the eligibility criteria on or before the last date of submission of applications.
- g) Applications received late or not in proper format or incomplete in any respect shall not be entertained.
- h) Applications by Government servants should be sent through the Administrative Authority concerned. In the case of the University Teachers/Employees, through the Registrar of their respective University and in the case of persons employed in the private firms and Institutions through the Head of the firm/institutions concerned.

- j) Impersonation or submission of false/ fabricated/ tampered documents or making incorrect/false statements by a candidate, will, render him/her liable for criminal prosecution.
- k) All enclosures attached with the Application Form should be self attested and the candidates shall have to produce the original documents relating to their age, qualifications, experience, fitness and other claims whatsoever at the time of interview.
- 1) The candidates are advised to write their name strictly as per Matriculation/ Higher Secondary Certificates.
- m) The interview call letter/s shall be sent through E-mail/ SMS on the e.mail address and mobile number mentioned in the respective application form/s.
- n) The University shall verify the antecedents of all documents of the candidates submitted at any time of appointment or during the tenure of service. In case, it is detected that the documents submitted are fake or the candidate has a clandestine antecedents/ background

and has suppressed the said information, his/her services shall be terminated forthwith and the action shall be taken as warranted under rules.

- o) Addendum/ Corrigendum/ Notice regarding this advertisement shall be uploaded on the University/ PRC website only.
- p) In case large number of applications are received, the short listing shall be carried out for which scheme will be notified separately.
- q) Candidates are advised to regularly check University/ PRC website for latest updates/ important instructions, released by the University from time to time. No separate intimation in this regard shall be given.

VI) OTHER TERMS AND CONDITIONS:

- a. A candidate should have a minimum of seven publications in the peer-reviewed or UGC listed journals and a total Academic/ Research score of seventy five (75) as per the criteria given in Appendix II, Table 2 of UGC Guidelines, July, 2018.
- b. Any publications in predatory/ dubious journals or presentations in predatory/dubious conferences shall not be considered for academic credit for selection and confirmation. With effect from 14.6.2019, research publications from journals indexed in UGC-CARE Listed Journals/ Scopus/ Web of Science listed Journals only would be considered for all academic purposes.
- c. Each API score must be supported by the documentary evidence in the Performance Based Appraisal System (PBAS) Proforma, without which no claim on account of Academic/ Research Score will be entertained. It is mandatory that the candidate mark Page No./s on all the supporting documents as in the Application Form.
- d. The details with regard to ISSN/ISBN, sole author/Coauthors/Joint publication, refereed/non-refereed/ indexed/ non-indexed and local/ national/ international status etc. must also be reflected in the publication part of PBAS proforma supported by documentary evidence.
- e. Documents required to be submitted along with Hard Copy of complete application form:
 - i. A self-addressed envelope bearing postage stamp worth Rs. 50/-
 - ii. One (1) set of Performance Based Appraisal System (PBAS) Proforma, four (04) copies of latest Bio-data along with and four (04) copies of seven (07) best publications as books and / or research/policy papers (which shall not be in any case attached to PBAS Proforma), in spiral binding only, along with other documents.
- f. Candidates who have been awarded post graduate/Ph.D. degree from Foreign University should enclose "Equivalence Certificate" issued by Association of Indian Universities (AIU), New Delhi without which their candidature shall not be considered and application form shall be rejected.
