Step 2: Submission of Application Form to the University of Kashmir

After successful registration on the NATS portal, candidates are advised to submit a copy of the Application Form downloaded from the NATS Portal at the Office of the Director, Institute of Technology, Zakura Campus, University of Kashmir, including all the relevant documents (self-attested xerox copies) which includes: Marks Card of the qualifying degree, Date of Birth Certificate, Domicile Certificate, Adhaar Card, and bank passbook/attested statement).

2. Shortlisting / Selection Process:

- The shortlisting of the candidate shall be done on the basis of the merit in their qualifying degree/diploma, wherever required.
- The selection process of the Interns will be based on the merit of their qualifying degree and the Interview performance in the ratio of 70: 30.
- Preference will be given to applicants who have proficiency in handling and operating engineering instruments relevant to their discipline.
- The selection will be done in a phased manner (as per the requirement), for which shortlisted candidates will be called for an Interview.

3. Stipend:

1	Graduate Apprentice	A stipend of Rs 24,500/= per month shall be paid to the Graduate Apprentice Intern. <i>Breakup:</i> (Rs. 4,500/= from National Apprenticeship Training Scheme through DBT) (Rs. 20,000/= from University of Kashmir)
2	Diploma (Technician) Apprentices	A stipend of Rs 14,000/= per month shall be paid to the Diploma (Technician) Intern. <i>Breakup:</i> (Rs 4,000/= from National Apprenticeship Training Scheme through DBT) (Rs 10,000/= from University of Kashmir)

F. Important points to Note:

- The bank account should be seeded with the respective Aadhaar card.
- The mobile number should be linked with the Aadhaar card.
- There should be no disparity in name between the Aadhaar card and the bank details mentioned in the passbook.
- The University reserves the right to increase/ decrease the number of Apprentice positions advertised herein above, without assigning any reason thereof.
