



Terms and Conditions

- The rates quoted shall be inclusive of wages of the driver/conductor.
- The vehicle provided must be in good condition and fit and comfortable in all respects.
- The cost of running repair/maintenance of the vehicle (minor or major), fuel, lubricants etc. will be borne by the Transport Company.
- University shall not be responsible for any accident/any kind of damage to the vehicle during the use of the same by the University.
- In case of any accident resulting in loss or damage to life or property, the sole responsibility for any legal or financial implication would vest
- with the transporter. The university shall have no liability whatsoever.
- The vehicles have to be supplied on all teaching days or as specified by the University administration.
- In case buses are unable to ply due to some unrest during the course of contract, the campus shall pay hiring charges for 10 days only. Beyond that period the campus shall in no case pay for the days when buses do not ply to this campus.
- The contract can be terminated for any reason with one month prior notice from either side.
- The undersigned reserves the right to reject any tender without assigning any reason thereof.
